****§505. Miscellaneous Capital Additions**

SPECIAL REQUESTS

● **C & C Marine and Repair, LLC (Contracts #20190003-ITE and #20190003-A-ITE):**

C&C Marine and Repair would like to formally request an amendment to our current ITE contract with the Louisiana Department of Economic Development. Specifically, we are requesting to amend Article IV Section 4.02 Exhibit A, for ITE-20190003/20190003-A, to decrease the required Annual Jobs and Annual Payroll for project years 2022 through 2030. The current Exhibit A of our ITE Contract lists the estimated Annual Jobs created at 35 new jobs. We are requesting that the estimated "Annual Job" created, be reduced from 35 jobs to 10 jobs. The requested amendment would more accurately reflect the current economic climate and allow C & C Marine the ability to meet the Annual Certification of Compliance reporting. The original figures listed in the current Exhibit A of the applications reflected the pre-pandemic hiring trends at C&C Marine and Repair, and do not accurately reflect the current economic realities facing our company, as well as the Marine Industry as a whole.

As you may know, C & C Marine and Repair has participated in and benefitted from the Industrial Tax Exemption Program since 2003. Despite the program changes that now require Local Votes to receive 80% exemption versus 100% exemption, C&C Marine has continued to rely on the program as an incentive to expand our workforce. If we are unsuccessful in getting this section of the Exhibit A amended, we fear the negative impact this could have on the company for many years to come. C & C Marine is already facing challenges with the local Parish Governing Authority who have voted to deny our last two contracts. Coupled with our increasing overhead costs and difficulties with attracting qualified new hires, this amendment is critical to C&C Marine and Repair's continued participation in the program.

C & C Marine and Repair has consistently expanded its workforce over the years. However, 2020 & 2021, have proven to be very challenging. The ongoing Covid pandemic put a strain on our business operations, and we experienced a reduction in the number of qualified "new" job applicants we received. Specifically, C & C Marine saw a significant decline in applicants for our job postings on LaWorks, Indeed, as well as in-person applicants. Due to the current hiring challenges, C & C is exploring alternative venues for hiring new employees, including social media, networking through local Community Colleges and Universities, as well the use of thirty -party employment agencies. However, there are no guarantees that these additional measures will produce the required number of additional hires.

As required by LED Motion/Rules, C & C Marine requested approval from Plaquemines Parish School Board and Plaquemines Parish Sheriff's Office to amend Article IV Section 4.02 Exhibit A for 20190003-20190003-A-ITE contracts, for project years 2022-2030, to decrease the number of new jobs and annual payroll. As stated on the attached Plaquemines Parish School Board Resolution and Plaquemines Parish Sheriff's Office letter, C & C Marine's request to amend Exhibit A was approved by both Local Authorities.

To meet our Annual Certification Compliance Reporting each year, and keep our 80% exemption, C & C Marine would greatly appreciate the LED Boards approval for the requested amendment to Exhibit A to decrease the required Annual Jobs and Annual Payroll for ITE-20190003/ITE-20190003-A, from 35 new jobs to 10 new jobs, with a required annual payroll of \$300,000 for 2022 to 2030.

C & C Marine and Repair has been in business, in Plaquemines Parish, since 1997. We have benefited from the Industrial Tax Exemption Program for many years, and we would like to continue to grow and prosper using the Industrial Tax Industrial Program.

SPECIAL REQUESTS [CONTINUED]

- **LA3 West Baton Rouge, LLC (Contracts #20161942-ITE, #20170443-ITE, and #20170504-ITE):**

LA3 has requested an amendment to their Exhibit A as follows:

Section 4.02(B) of the Agreement provides that during each Project Year, the Company shall maintain Required Annual Jobs and Payroll as set forth therein, including 4 Annual Full Time Jobs and \$160,000 in Required Annual Payroll. The Agreement permits the Annual Jobs and Payroll requirements to be achieved through a Qualified Contractor. In 2021 (the first full year of the Agreement and reporting period) the Company provided, through its Qualified Contractor, the following Services to the Project: (i) 4 full time employees of a Qualified Contractor with payroll of \$132,789.00; and (ii) 2 individual independent contractors contracting directly with the Qualified Contractor, with a payroll of \$48,672.00 (for a 2021 total of \$181,461 plus health benefits). Both the full-time employees and the independent contractors were offered the option to participate in health insurance benefits that were similar to other salaried employees of the Qualified Contractor, providing coverage for basic hospital care, physician care, and health care with a value in excess of \$1.25 per hour.

The Company sincerely believes it has complied with the spirit of the Agreement governing the minimum required annual payroll of the Company. However, the Company does find the language of the Agreement to be somewhat unclear as to the exact formal requirements for Jobs and Payroll that must be met under its terms. As such, out of an abundance of caution, the Company respectfully requests an amendment to the Agreement to clarify the language as set forth below and to apply at least for the first Project Year or as the LED otherwise determines appropriate.

In further discussions with the Company, they have also requested that the Board deviate from its usual practice of having Exhibit A amendment be prospective, only, and for the Effective Date of the amended Exhibit A to be January 1, 2018.

Considering these projects had one of the first Exhibit A's, the amended Exhibit A has also been brought up to date with the addition or adjustment of various sections to be current with today's Exhibit A terms and conditions, e.g. reporting deadlines and default payments.

● **Lamb Weston Inc. (Contract #20200134-ITE):**

Upon approval by the Board of Commerce and Industry at the February 23, 2022 meeting, application #20200134-ITE was sent to the Richland Parish local bodies for consideration. Rules provide 30 days to provide notice to LED that the Police Jury and School Board will take action on the application and an additional 30 days to take action approving or denying the application.

LED received a request from Lamb Weston Inc. to petition the Richland Parish Police Jury and Richland Parish School Board decisions to deny their ITE property tax abatement. Lamb Weston is requesting these denials be deemed approved and has provided supporting documents from the local bodies.

- February 24, 2022 – LED notifies locals of BC&I approval by email
